

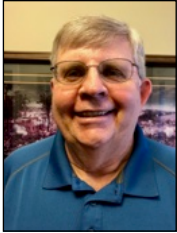

You may ask sometimes, what do I get for my dues? Fifty percent of our budget goes to pay for our speakers and rent for Hatch Auditorium. Besides bringing in world renowned speakers, every year we try to give speaking opportunities to up-and-coming historians. They must prove themselves before we allow them to speak at the BCWRT, but speaking at the BCWRT allows speakers a rare opportunity to talk before large crowds of 350+ attendees.

Every year we also contribute a \$1,000 scholarship to a UNCW Master's Program student. One example of the results of the UNCW Scholarship is Samuel Flowers. He received our scholarship in 2021. Since his graduation he has taken a position as Assistant Professor of History at Louisburg College in Raleigh. He is also a contributing member of the Emerging Civil War. I spoke with Sam at the most recent Emerging Civil War Symposium (August 7-9, 2026) and he was very appreciative of the scholarship and the opportunity it gave him to continue his master's program. At the Emerging CW Symposium, he participated in a couple of panel discussions and assisted in the running of the meeting. Since 2025 he has written numerous articles on various CW topics and several book reviews. You will find one of his articles in this issue on page 6. Sam is just beginning his career as a guest speaker for various CW Round Tables. On January 7, 2027, he will be giving a presentation at the Cape Fear Civil War Round Table. The scholarship program is just one way to support bringing new blood into the study of history and particularly the Civil War.

The other major expense we have is donating to a local CW battlefield restoration. In the past fifteen years, we contributed over \$78,000 to this effort. Our latest is in partnership with Wade Sokolosky and the Blue and Gray Education Society. The First Battle of Kinston Battlefield Park in Kinston, NC needs a major update. This battlefield was established 20 years ago. The BCWRT is contributing \$1,600 to fund the replacement of 11 interpretive panels. The Blue and Gray Education Society will raise additional money to repair Harriet's Chapel.

Everyone can take pride in the efforts to further the education and knowledge of the Civil War. If you go to the local sites of Fort Anderson, Fort Fisher, Bentonville, etc., look for the BCWRT logo on various markers, etc.

Living History Brought to Life: Meet Gen. Robert E. Lee

We welcome returning living historian Thomas Jessee in full Confederate uniform portraying General Robert E. Lee at our first meeting of the new season. Known for his meticulous attention to detail and compelling first-person portrayals, Jessee will offer us a captivating look into the mind, character, and legacy of one of American history's most prominent military figures.

Rather than a standard lecture, this immersive presentation provides a deep dive into Lee's early life from his West Point days and antebellum military career through the high-stakes battlefield decisions of the Civil War.

Ask General Lee. One of the most compelling features of Lee's visit will be his desire to interact with us, his audience, to answer questions and reveal perhaps little known facts and events throughout his life.

This might include his early childhood, his relationship with wife Mary Custis and their seven children, or his life after resigning his commission. His comments usually include little known facts rarely if ever found in history books. Jessee's appearance in Lee's uniform will seem so genuine, it will be as if General Lee is there in person, just saying it like it was!

About the Presenter



Thomas Jessee is a well-known living historian and reenactor who has portrayed Lee at major national events since 1969, including the 150th anniversary commemoration of the surrender at Appomattox Court House. He is approved by the National Park Service to portray General Lee across the national park system, including the Appomattox visitor center film. His busy schedule includes frequent speaking engagements at historical symposia, schools, and Civil War round tables. Coincidentally, he serves as the Commanding General of Confederate Forces for the annual reenactment of the Battle of Olustee. This battle will be discussed by Capt. Ed Gantt (U.S. Navy, Ret.) at our October 5th meeting.

Tour of Bennett Place State Historic Site Site of the Confederate Surrender on April 26, 1865

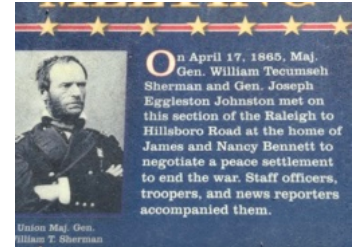

This past April, Bennett Place held the 161st Commemoration of the Surrender of General Joseph E. Johnston and his Confederate Army.



This surrender is less well known than Appomattox, but involved the surrender of a larger number of Confederates and the end to the entire war. Over the course of three days (April 17, 18, and 26, 1865) General William Tecumseh Sherman and General Joseph Johnston deliberated the terms of surrender and peace at Bennett Place, a 189-acre Piedmont, North Carolina farm owned by James and Nancy Bennett.

In the final resolution, on April 26, 1865, 89,270 Confederate soldiers who were still actively fighting in Florida, Georgia, South Carolina, and North Carolina officially surrendered. This submission was the largest of Confederate soldiers in the American Civil War.



Bennett Place is located in Durham, NC and is a NC State Historical Site. It consists of a visitor's center, museum, monuments and replicas of the Bennett's home and surrender site. The Visitor's Center has a research library and theater with a 17-minute movie, "Dawn of Peace," about the surrender and a small museum.

A tour of the site will take less than two hours and is easy to get to.

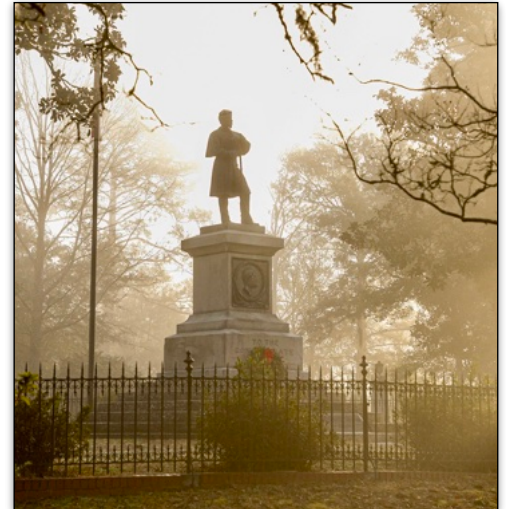


Dr. Chris Fonvielle shaped by the conflict. Dr. Fonvielle will guide attendees through key sections of the cemetery, sharing insights into the individuals buried there, the city's role during the war, and the cultural significance of Victorian-era memorial traditions.

"Oakdale is one of the most evocative historic sites in the region," Dr. Fonvielle notes. "Its monuments and stories offer a powerful window into Wilmington's Civil War experience."

The tour will last approximately two hours and will include opportunities for questions and discussion. Comfortable walking shoes are recommended.

Sign-ups will be held at our September 1 meeting. Space is limited, and early registration is encouraged. The cost will be \$15 per person.

Wilmington National Cemetery

After the capture of Fort Fisher and the fall of Wilmington in January 1865, the handling of the dead was generally battlefield internment.

"In 1867, land was purchased from a local Wilmington resident for the construction of a national cemetery. Most of the original interments were remains removed from the Wilmington City Cemetery, Fort Fisher, Fort Johnson and the surrounding area. An inspection dated May 13, 1870, reports 2,039 interments, including 698 known and 1,341 unknown graves marked by headboards."

The graves of the known included 55 USCT soldiers. Scorned as a "Yankee" cemetery by some neighbors, this cemetery became the place where Union veterans and African American citizens came together — especially on Decoration Day each May 30 — to honor those who paid freedom's ultimate price. Today, visitors also reflect on freedom's ongoing cost as soldiers, sailors, and marines of later wars fill the cemetery. It is a fitting place to give voice to Paul Laurence Dunbar's poem to *The Unsung Heroes* of the USCT.

My Civil War Brady Bunch: The Flowers Family at War

In 2021, Our BCWRT 2021 scholarship was awarded to Samuel Flowers who received his M.A. from UNCW with a concentration on American History. He is an Assistant Professor of History at Louisburg College in North Carolina.

In May 2025 Samuel became a member of Emerging Civil War where he contributes book reviews and is a guest author on a variety of Civil War subjects including his five-time great grandfather, William Lovelace "Love" Flowers, and his 11 sons who served in the Confederate Army.

Emerging Civil War recently posted a "Question of the Week" asking if anyone had an ancestor who had fought in the Civil War. The comments were filled with very interesting stories of soldiers and sailors who, if not for their descendants, would have been lost to time. I thought that telling my family's story would give further documentation of ordinary soldiers who otherwise would have been forgotten.

My five-times great-grandfather went by William Lovelace "Love" Flowers. Love, the son of a Revolutionary War veteran, resided in Marion County, South Carolina and was considered a leading patriarch at around 63-years-old. A religious man, Love lived up to his name, and between two marriages, he fathered twenty-four children: two sons from his first wife and the rest from his second. According to an 1860 census, Love and his family were farmers just like many were in Marion County, a

region of the Palmetto State that was predominantly rural.

By the time the war started, it is safe to say that Love was a staunch pro-Confederate and believed in South Carolina seceding from the Union. Of his twenty-four children, thirteen lived to adulthood, and eleven were military-age men eager to serve the Confederate cause. In my research and knowledge of the American Civil War, I do not know if any family had more brothers in one family who served.

According to some records available, these are the names and regiment information found:

Pvt. Elly Flowers, Company L, 21st SC Infantry

Pvt. Henry Flowers, Company F, 4th SC Cavalry

Pvt. Joel A. Flowers, Company F, 4th SC Cavalry

Cpl. John Flowers, Company I, 10th SC Infantry (my 4x Great-grandfather)

Pvt. Nathan Flowers, Company L, 10th SC Infantry

Pvt. William Flowers, Company L, 21st SC Infantry

Pvt. Williamson Flowers, Company D, 10th SC Infantry

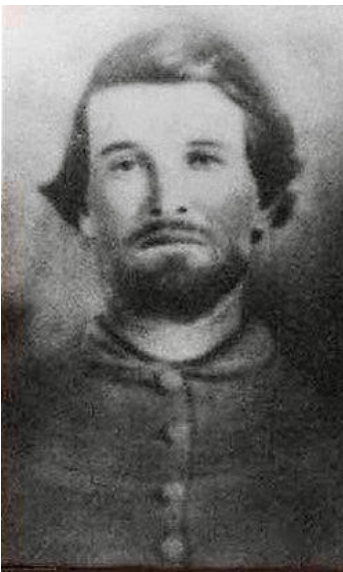
Civil War Notes...Continued

It's safe to say that for going to war, the Flowers believed it to be a family affair and something they would all do together. Unfortunately, of the eleven brothers who went to fight, only six would return home, while the rest would perish in less discussed areas of the Civil War. The Flowers clan and their military service are closer to the reality of what most soldiers endured. Many soldiers did not go home and tell stories from the battlefield with visions of glory and grandeur. Some brothers were spared the fate of campaign and combat. William, Clayton, and Elly were mustered out of service in 1862-1863 due to enlistments running out and old age. As for the others, they experienced the realities of soldier life.

By 1863 the Flowers brothers of the "Bloody Tenth" started to drop like flies. In mid-September, Burnett contracted dysentery and died of the disease at a

field hospital near Atlanta. Soon afterward, during the siege of Chattanooga, the regiment was under heavy fire while defending Confederate positions along Missionary Ridge.

Nathan was captured by Union soldiers and sent to Rock Island, a prisoner-of-war camp located in Illinois. He contracted tuberculosis while in camp and died in January 1865. By 1864, only Archibald, Barnabas, John, and



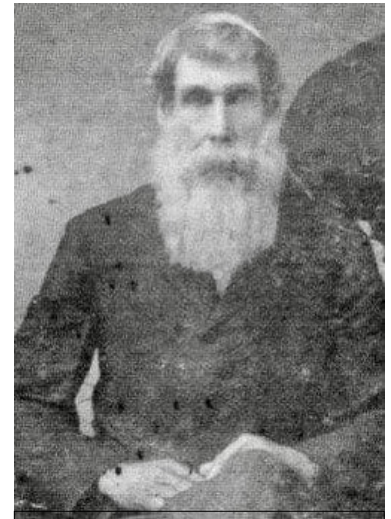

Williamson were left in the regiment.

Tragedy continued befalling the surviving brothers into 1864. During the battle of Resaca, early in the

Union campaign against the Confederate hub of Atlanta, Barnabas was wounded in the leg and sent home for the rest of the war to recover. The other brothers survived the rest of the war as they and their regiment battled through the Atlanta Campaign, Franklin, Nashville, and Bentonville. Aside from the brothers who were discharged early in the war, these three had slugged it out through some of the fiercest fighting in the Western Theater.

For Love Flowers, he lost five sons, gone forever and buried somewhere far away from the family plot. Even the sons that did return home were still casualties from the war. Some came home wounded physically, while others were forced to hold traumatic images of visceral combat in their minds for the rest of their lives.

The Flowers brothers represent the horrors and realities of the American Civil War. Like so many others in the war, disease killed more than combat, and many were infected in camp or as a POW. Large families joined and fought in the same regiments, only for battle and disease to pluck away their loved ones. Those who returned home after fighting were scarred both physically and mentally and attempted to make sense of the destruction they had witnessed. For the Flowers brothers, there was no glory and sense of adventure by the end of it, only pain and mourning.

Visit to Chickamauga and Chattanooga National Military Park

In June this year, our Ladies' Forum leader, Robbin Smith and her husband, Stephen, traveled to Georgia to visit Chickamauga and Chattanooga National Military Park for a tour led by Jim Ogden, Chief Historian of the Park and respected Civil War speaker.

The tour began with a classroom style lecture with Jim Ogden demonstrating military movements of the Union and Confederacy armies on a tarp on the floor. Throughout the day at every location, he made the battle come alive as if we were there.

We traveled by bus to the Chickamauga Battlefield Visitor Center in Fort Oglethorpe, GA and then on to the battlefield. Monuments were allowed to be erected for every state that had soldiers who fought in the war (including

one to the 2nd Ohio Infantry, Scribner's Brigade, 14th Army Corps with an [upside down acorn](#)). Also on the grounds was the Snodgrass House that was used to treat wounded (mostly Union) soldiers. The last area we visited was the Chattanooga National Cemetery.

"The Women's Civil War Museum" in Bardstown, KY



In July, my husband Mike and I visited [The Women's Civil War Museum](#) in Bardstown, Kentucky. It is self described as "the only museum in America dedicated exclusively to the contributions of women during the Civil War."

The museum contains extensive exhibits about nurses, such as Fannie Ricketts, the Sisters of Charity, and Clara Barton. It also tells the stories of women who dressed as men to accompany and fight with their husbands or who enlisted on their own - among them Kady Brownell and Albert

Cashier - as well as Sojourner Truth, Harriet Tubman, and spies including Elizabeth Van Lew and Mary Elizabeth Bowser. It is wonderful that this museum exists and we were thankful that we were able to visit.

What luck to find such a combination in Bardstown - the Bourbon Capital of the World - where distillery tours and tastings sit side-by-side with Civil War history.

April 8, 1865

Appomattox Negotiations

On April 8, 1865, General Ulysses S. Grant was having a hard night.

His army had been harrying Confederate General Robert E. Lee's for days, and Grant knew it was only a question of time before Lee had to surrender. The people in the Virginia countryside were starving, and Lee's army was melting away. Just that morning a Confederate colonel had thrown himself on Grant's mercy after realizing that he was the only man in his entire regiment who had not already abandoned the cause. But while Grant had twice asked Lee to surrender, Lee still insisted his men could fight on.

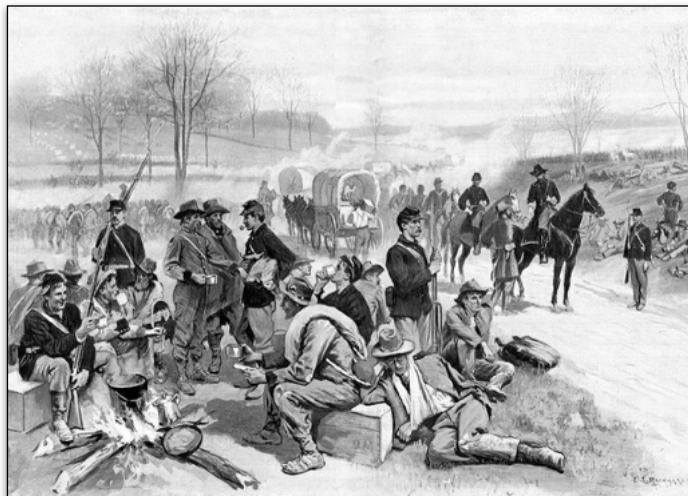
So on the night of April 8, Grant retired to bed in a Virginia farmhouse, dirty, tired, and miserable with a migraine. He spent the night "bathing my feet in hot water and mustard, and putting mustard plasters on my wrists and the back part of my neck, hoping to be cured by morning." It didn't work. When morning came, Grant pulled on his clothes from the day before and rode out to the head of his column with his head throbbing.

As he rode, an escort arrived with a note from Lee requesting an interview for the purpose of surrendering his Army of Northern Virginia. "When the officer reached me I was still suffering with the sick headache," Grant recalled, "but the instant I saw the contents of the note I was cured."

The two men met in the home of Wilmer McLean in the village of Appomattox Court House, Virginia. Lee had dressed grandly for the occasion in a

brand new general's uniform, carrying a dress sword; Grant wore simply the "rough garb" of a private with the shoulder straps of a lieutenant general.

But the images of the wealthy, noble South and the humble North hid a very different reality. As soon as the papers were signed, Lee told Grant his men were starving and asked if the Union general could provide the Confederates with rations. Grant didn't hesitate. "Certainly," he responded, before asking how many men needed food. He took Lee's answer—"about twenty-five thousand"—in stride, telling the general that "he could have...all the provisions wanted."

By spring 1865, the Confederates who had ridden off to war four years before boasting that their wealthy aristocrats would beat the North's money grubbing shopkeepers in a single battle were broken and starving, while the Union army, backed by a booming industrial economy, could provide rations for twenty-five thousand men on a moment's notice.

The Civil War was won not by the dashing sons of wealthy planters, but by men like Grant, who dragged himself out of his blankets and pulled a dirty soldier's uniform over his pounding head on an April morning because he knew he had to get up and get to work.

Union General James Ricketts was seriously wounded and captured at the First Battle of Bull Run in July 1861. His wife Fannie obtained a pass from J.E.B. Stuart, a friend of her husband from before the war, to search the battlefield for James. She found him in a makeshift hospital and went with him when he was moved to a Confederate prison. She remained there to care for him and other Union prisoners until his exchange and release. She again nursed him back to health when he was badly injured after his horse fell on him at the Battle of Antietam and a third time when he was shot through the lung at the Battle of Cedar Creek.

After General Ricketts retired from active service, they lived in Washington, D.C. until his death in 1887. Fannie died in December 1900 and is buried next to her husband in Arlington Cemetery.

Baked Custard Pie

1861



Mix a quart of new milk with eight well-beaten eggs, strain the mixture through a fine sieve, and sweeten it with from five to eight ounces of sugar, according to taste; add a small pinch of salt, and pour the custard into a deep dish, with or without a lining or rim of paste; grate nutmeg or lemon rind over the top and bake it in a very slow oven.

Soldiers, Spies, Femme Fatales

We have learned in the past few years more about women disguising themselves as men to don a uniform to serve their country. Information has surfaced revealing the names of more women willing to temporarily set aside the identity of their gender.

Statistics:

- It is estimated 1,000 women served
- 70% fought for the Union
- 30% fought for the Confederacy
- Of the 40% casualty rate, 14% of these were women
- 18% of the soldiers were captured by the enemy. 16% of these were women
- 72% of the women were discovered as a result of a casualty or accident
- 17% served openly
- 10% were never discovered
- The average length of service was 16 months
- 11% died in the military
